

## **EVENT DETAILS**

3-on-3 tournament

Males only; 16 years old and up

1st Place: Trophy and \$300 cash prize    2nd Place: Trophy and \$150 cash prize    3rd Place: Trophy

Registration before March 31st: \$50    Registration after March 31st: \$75    Deadline: April 8th

Driver's License or State identification card only forms of ID accepted for all participants

Game times: 10am-until; Tournament intermission for free throw and 3-point contest at 1pm

Food vendors will be on-site after 1pm

## **GAME RULES**

Team Roster: 5 Players 3 players + 2 substitutes (No transfers); 3 players must be present at beginning of game or else the team must forfeit.

Referees: 1 or 2

Time & Score Keepers: 1 or 2

Timeouts: 1 per team (1 minute and 30 seconds) for duration of entire game

Initial Possession: Coin flip

Scoring: 1's and 2's (regular game played "straight" to 7; Championship game to 15)

Shot Clock: 12 seconds

Game time: Up to 15 minutes; team with higher score wins at time expiration

Free throws following a shooting foul: 1 free throw; possession goes to defense

Foul limit per team: 6 fouls

Penalty for team fouls 7, 8, 9: 2 free throws

Penalty for team fouls 10+: 2 free throws+ball possession

Following a defensive rebound, air ball, steal or anything else: Ball is to be dribbled/passed by or to a player with both feet behind the arc

Following a jump ball: Alternate possession

Following a scored goal: Alternate possession (no "make it, take it..."); ball is "live" at the top of the key.

Substitutions: Dead ball situations; player must be checked-in by referee

5-minute rest intervals between games; Games will be played simultaneously on both ends of court.

TRASH TALKING, BULLYING, FIGHTING, DRESPECT TOWARD REFEREES, ETC. WILL NOT BE TOLERATED AND WILL BE AN IMMEDIATE CAUSE FOR DISQUALIFICATION

### **“He’s that Fire” Free Throw Competition**

5 shots from the free throw line. Top scores advance to the next round in competition bracket.

Cost of entry: \$5 (\$1 per ball)

1<sup>st</sup> Place: Trophy

### **“The Hot Shot” 3-Point Contest**

10 shots at designated spots around the arc. Top scores advance to the next round in contest bracket.

Cost of entry: \$10 (\$1 per ball)
